

Managers' Report - October 2024

<u>To consider the letter received form Cornerstone solicitors regarding their request for a site investigation at Phillimore Rec for a possible phone mast (Feb24 – Agenda item 10 & Sept24 – Ag item 7)</u>

- a) That Russell Cooke Solicitors contact Cornerstones solicitors to obtain this undertaking regarding fees and to arrange a date for when the site visit can take place. **still negotiating final fee structure.**
- b) That Russell Cooke Solicitors and TDC Property continue to negotiate with Cornerstone re the site investigation agreement.
- c) That if Russell Cooke Solicitors are unable to reach an agreement with Cornerstone's solicitors before the court deadline date for a response, that APC will ask them to file a response at the cost of £750 funded from the 'Professional Fees' budget. This matter did go to court and there was a ruling made that APC must comply with Cornerstone's request to carry out a site investigation at P Rec sols did act at a cost of £650.

<u>To receive an update on the Phillimore Rec Improvements -- Cafe Project (May24 – Ag item17, June24 – Ag item 15, July24 – Ag item 12, Sept24 – Ag item 14)</u>

- a) The report also indicated the design for the gate that will replace the field gate which is also part of the improvement project **ordered 5/8 to be fitted w/c 21/10.**
- b) That APC note the in May the project manager reported on possible increase in fees due to programme delays beyond original quote date, and therefore that the budget is amended by £3,482, this being an increase in the fee for the architects IID which is to be debited from contingencies.
- c) That all variations 14 and 24 -- 46 are agreed subject to scrutiny for fairness by the QS and Project Manager.

To decide any response to the appeal to the Secretary of State regarding the HertsCC ROW decision to reject the application to have a designated footpath from A54(Rose Field) to A70 (Second Pitch/Salters Field) – (June24 – Ag item 10). Resolved that APC informs the Secretary of State that it fully supports the decision made by the HertsCC ROW division.- Planning inspector advised 8/7, appeal will be considered after 28/8 by inspector, awaiting decision - chased 18/10 no decision yet.

To consider the erection of a further bench on Radlett High Street in recognition of a past Chairman of the council (July24 – Ag item 9)

ALDENHAM PARISH COUNCIL

To approach HBC Ward Clirs for funding towards the purchase and installation of the bench. – **HBC have confirmed** allocation of £1,000 from Ward Clirs just awaiting funds.

To consider whether to apply for the 'Local Council Award' (July 24 – Ag item 11)

—Application made, feedback received and acted upon and full application made 11th October 2024.

To consider the tenders for the 2024 tree works at Phillimore Recreation Ground. (Sept24 – Ag item 13)

A report on this matter had been circulated prior to the meeting. There was some discussion as to whether any of the trees were near neighbouring gardens etc, and whether APC can retain some of the wood that is cut down. It was then;

Resolved that 'Longacre' are awarded the contract within a fixed price of £10,290 from the tree budget. – **contract agreed just waiting for start date.**

Re: HBC enforcement notices served on APC re Allotment Track.

As reported previously APC met with officers in May 2024, hoping that a site visit to understand their concerns regarding the height of the track, that had led to HBC issuing an enforcement notice on APC asking for the track to once again be taken up andre-laid at a lower level where it bordered one of the houses in Flm Walk

It was agreed that the track was compliant, and eventually HBC did confirm that the chair of the planning committee had given delegated powers to the Head of Planning for his department to issue a notice to APC that condition eight was signed offand the matter was now closed.

HBC also then question condition 3 re materials used on the track and asked APC to supply information which it duly did and this condition was also signed off.

There is no enforcement action from HBC now outstanding.

Gates to Phillimore Rec Car Park

Just to note that the vehicle delivering the hedging plants for the café surround managed to hit the newly installed gate post and damage it beyond economic repair.
