To agree the bank balances as at 31st July 2021.	Finance & General Purposes Committee Meeting 13 th September 2021

Background

As stated in the final auditor's report for 2020/21, it is a requirement that the council bank balances are reconciled on a regular basis by councillors, who are independent from the process of making payments, and updating the cash book.

The procedure in Aldenham Parish Council (APC) is that the assistant manager processes all income and expenditure, and reconciles the cash book monthly with the bank statements. The CM carries out an independent check monthly, and also reviews the debtors and creditor list.

It is good practice for a member of APC (normally F&GP Chair) to also carry out a random check on invoices against payments made etc, this was last carried out in February 2021. In July 2021 the F&GP committee agreed the April reconciled bank balances, which were then signed by the F&GP Chairman.

At this meeting the committee are presented with a copy of the cash book reconciliation for July month end, (attached) performed by the accounts package and a copy of the bank statement to which the cash book has been reconciled to.

APC has the following accounts;

- Barclays Current account = Balance as at 31st July £347,580.42 balance as at 30th April £501,028.22. APC have received first half of its precept and CiL receipts in April totalling nearly £390,000. £100,000 was invested with United Trust Bank and the remainder is budgeted for grants to RCT £20,000 and staff expenditure.
- CCLA Public Sector account = Balance as at 30th July £407,328.90 balance as at 30th April £407,298.72. The difference is three dividend payments received.
- HertsmereBC = Balance as at 31st July £0.00 balance as at 30th April £500,000 1-year bond matured on 29th July 2021.
- Close Bros investment = Balance as at 30th July £163,758.38 balance as at 30th April £162,869.96 -The difference is interest paid in July.
- Unity Trust Bank current account = Balance as at 30th July £507,833.84 -balance at 30th April £5,095.00 this is a new current account opened on behalf of APC to which Barclays is being transferred to. Hertsmere 1-year bond matured on 29th July 2021 was transferred to this account.
- United Trust Bank = Balance as at 30th July £100,000 -,1-year bond opened in March 2021, no change since April.

Recommendations

That the committee agree the balances on the cash books, and authorises the F&GP Chairman to sign these reports.

Reasons for recommendation

This meets the spirit of the recommendations from the internal auditor and assures the public that APC have budgetary excellence.

Alternative options

APC could solely rely on the F&GP Chairman to carry out spot checks randomly and report back to the committee with his/her findings. This should be carried out anyway but it is only one check. Alternatively, these reports are tabled monthly at the Full Council meetings. However, this duty is within the terms of reference for this committee.

Financial Implications

None.

Risk Management Implications

Failure to carry out this check could lead to APC being reported to the external auditor for not performing its scrutineer role and lead to the insurer not honouring any fidelity claim.
